Manufacturing Safety Professional (MSP) Requirements

To obtain the designation of MSP, twelve (12) mandatory courses or their equivalents" are required:

Committee Level 1 & 11	Fall Protection (or TTT)
Forklift TTT	Inspections
Internal Auditor	Investigations
Respiratory Protection (or TTT)	Return to Work
Safety Essentials for Supervisors	Safety Management System
Risk Assessment/Job Hazard	WHMIS 2015 TTT
Analysis/Safe Work	

Course equivalency will be considered if a detailed syllabus of the course in question is submitted to SASM.

Additionally, four (4) elective courses from the following list must be taken:

Aerial Lift TTT	Back, Hand & Eye	Confined Space
Ergonomics	Lockout Tagout TTT	Overhead Crane TTT
Rigging	Skid Steer TTT	Telehandler TTT

Maintenance education is also required in order to keep the designation. A total of eight (8) maintenance credits are required every three (3) years. **Credits can be acquired as follows:**

Professional Pursuits

- Continuing safety practice in a company with greater than 50% safety-related activities for a minimum of 900 hours per year 1 credit
- Involvement in the SASM CoR Review Committee, SASM Program Development Steering Committee or Sub-Committee – 1 credit
- SASM Quarterly Meeting 0.5 credits
- Saskatchewan Safety Council Industrial Safety Seminar 0.5 credits
- Saskatchewan WCB Compensation Institute 0.5 credits

SASM courses taken above the elective requirement are allotted credits as follows:

- Aerial Lift TTT, Overhead Crane TTT, Telehandler TTT 4 credits each
- Rigging, Confined Space, Ergonomics, Back, Hand & Eye 2 credits each
- Lockout Tagout TTT 1 credit
- Lunch and Learn session 0.5 credits

Other Approved Safety Courses:

- St. John's/Red Cross First-Aid Class B & CPR 6 credits
- St. John's/Red Cross First-Aid Class A & CPR 3 credits each
- 3-day Course (minimum 18 hours) 4 credits
- 2-day Course (minimum 12 hours) 3 credits
- 1-day Course (minimum 6 hours) 2 credits
- Half Day Course (minimum 4 hours) 1 credit

Courses could include, but are not limited to: H&S, Confined Space Rescue, Large PME, TDG, Mobile Crane, etc.– 3 credits each
